I hope many of you share that same sentiment. Being part of a **great community** is such a blessing, especially during this difficult time filled with so many challenges and concerns. We see the school staff doing a great job in keeping the kids connected and delivering that quality education experience we are so used to. Likewise, the Village staff and board are being proactive and diligent on their work to benefit the Village, staying up to date and connected with other communities learning together how to deal with Covid19 related issues. This was put on display with the excellent job the Village staff did to prepare our polling location for the spring election. **Thanks to staff and all the fantastic volunteers.**

I want to take this opportunity to make sure you are aware of some recent changes. The Village welcomes new board members **Sheena Kaatz** and **Kelli Corbin**. Congratulations to them! Additionally, the board has decided to open a position for a **Village Administrator/Public Works Manager**. The hope is that this individual will be an advocate for our Village at many different levels.

Perhaps the most visible upcoming change for residents will be in regards to **garbage billing and services**. As previously communicated, in order to maintain the advantages of having a single garbage hauler, the Village needs to assume billing administration for garbage services per Wisconsin's anti-trust law (Wis. Stat § 133.03). One thing that won't change is the garbage hauler, as Advanced Disposal was selected during the bid process to retain those services. **Starting July 2020, Advanced Disposal WILL NOT send Village residents a bill;** the garbage bill will become **part of the Village water/sewer bill**. However, some of the services will change. In their bid, Advanced Disposal **DID NOT include prepaid bags** for service and only offered **recycling pickup every other week**. The cart size service you currently receive from Advanced Disposal is the same size service the Village will establish your account as. If you'd like to change your cart size, please contact the Village office at 715-877-2177. Please feel free to contact me or any of the other board members with any questions or concerns.

35 gallon cart—\$12.23/mo

65 gallon cart—\$14.23/mo

95 gallon cart—\$16.23/mo

Pickup for **RECYCLING** see below, **every other Friday**

West of State Street—begins July 3

East of State Street—begins July 10



Placement of carts: 3 feet from curb & fixed objects
2 feet between containers
Containers face toward street

Billing issued in arrears to service. **First bill** including garbage services will be issued on the **July 31 water/sewer bill**, with a due date of August 20th.
