- 1. Call to Order: 6:30 p.m., Village Hall Meeting Room, 122 E. Lincoln Ave., Fall Creek
- 2. Pledge to Flag
- **3. Roll Call**: Members Present: Village President Chester Goodman, Trustees Joyce Aldrich, Bob Jenkins, Matt Mattoon (via telephone), Karen Strasburg, Dane Zook. - **4. Certify Open Meeting Law Requirements Have Been Met**: A notice of the meeting and an agenda was posted in the three public places and local newspapers were notified.
- 5. Adopt Agenda:
 - MOTION (Mattoon/Aldrich) to adopt the agenda as printed. PASSED, without negative vote.
- **6.** Act on Minutes:
 - MOTION (Zook/Mattoon) to approve the 5/13/19 Plan Commission, 5/13/19 Special Village Board, 5/13/19 Regular Village Board, and 6/4/19 Plan Commission meeting minutes. PASSED, without negative vote.

Consider Sign Permit Application in Downtown Business District for 115 E Lincoln Ave: President Goodman reported information from the Village Architect and Zoning Administrator recommending the applicant be required to put a frame around the sign. Goodman stated this recommendation came in after the Plan Commission meeting, but the Village Board could consider it, if they desired. The Plan Commission recommendation was to accept the application, as is.
